Pre-listed weaning worksheets for Spring 2006 calf crop

Worksheets were mailed out the first week in August along with the July statement. These worksheets have been pre-printed to help members submit information from their Spring Herd Inventory for the 2006 calving season. We realize that for most members these are being sent out ahead of weaning time. Therefore, just because you have received the worksheets does not mean that you are required to return them immediately. If you are weaning at a much later date, then simply hold on to the worksheets and submit the information after you wean your calf crop.

Fall 2005 Calf Crop - No Progeny Reports

This report is sent to all members who have active Fall calving cows that have not reported a record for the 2005 calving season. The report was mailed around August 15th and must be returned to the National Office postmarked no later than September 16th to avoid inactivation of the dam. In order to fulfill the requirements for THR a calf record through weaning is required. If a female loses her calf at birth or the calf dies before weaning, the information regarding that calf is still very important. If the female did not have a calf in Fall 2005 (July 1st - December 31st) then supply a reason code for the dam:

- 1 - open, missed calving opportunity
- 2 - ET program/donor dam
- 3 - Moved to next calving season (*Spring to Fall or Fall to Spring*)
- 4 - ET program/recipient cow
- 5 - aborted/premature

Tattooing Procedures

- The calf's left ear should be tattooed with the individual identification number. Tattoo should be no more than five digits and may carry the international birth year codes. Code for 2006 = S
- The calf's right ear should be tattooed with the first owner's Tattoo Code Letters. "First Owner" is identified as recorded owner of the dam or embryo at birth of calf.
- Tattoos must not be duplicated for animals of the same sex and year within the same herd according to the Rules and Regulations. (*To avoid confusion, we recommend that tattoos not be duplicated.)
- Which ear to tattoo? If you are standing beside the animal, facing the same direction then your left is their left and your right is their right.
- Please review the TATOO FAQ, found on the web site under membership information.

Reason Code 3 - Moved to Next Calving Season

This reason code should be used to indicate when a female is listed in an inventory season and will be calving in the next inventory season. For example, if a female is currently listed in the Spring 2006 Inventory and will not calve in the Spring of 2006, but is bred to calve in the Fall of 2006 then she should be moved by submitting a reason code 3 moved from Spring Inventory to Fall Inventory.

DO NOT use reason code 3 to indicate a female that is currently listed in the Spring 2006 Inventory and will not calve in the Spring of 2006, but is held open to calve in the Spring of 2007. In this case, a

reason code 1 should be submitted to indicate the female was open for the Spring 2006 calving season and then she remains in the Spring Inventory until the reporting process begins for 2007.

Please double check the web site under REDS or with the National Office before submitting Reason Code 3 for a female in order to avoid moving a female twice in one year. The herd inventory season of any animal can either be viewed on the Herd Inventory for animals 16 mos. of age or older, or view the Whole Herd EPD Report, which will list all active animals for a member account, regardless of age.

Sire Summary Deadlines

In order to guarantee inclusion in the 2007 Sire Summary, all work must be submitted by: Paper - must be postmarked by November 1, 2006; Electronic - must be received by November 8, 2006

By submitting your information by these dates, we guarantee that we will enter your records so that they will be included in the data sent to the National Cattle Evaluation. However, if you are not ready to wean by the deadline then you can either choose to send just the birth information and submit weaning updates at a later date or you could wait to submit the information when you do wean the calves. Registration Update

Dam Summary Available on-line

Once you have logged into REDS, a selection page (Figure A) will be displayed with the different reports/inventories available to members on the web site. Click on Dam Summary Report, this will take you to a menu page (Figure B). On the menu page:

- Select birth year as ALL (Figure B) to view the report for all active females under the member account.
- Select a particular year (Figure C) to view the report for all active females born in that year.
- Select cows listed below and then enter one or several registration #s in the box to view a limited number. (Figure D) Enter one registration # per line or cut and paste a list of registration #s from another document. If you wish to reset the box for additional registration #s, click the clear registration numbers' button.
- Also, click a particular field by which you would like to sort the report before viewing.

Once the selection is determined, click the submit button. The next page (Figure E) will display each animal that was selected in a PDF file.

Ultrasound Summary Report Available on-line

On the selection page (Figure A), click on Ultrasound - Summary Reports, this will take you to a menu page (Figure F). The menu page will ask for the birth year of the calves scanned, then click submit. The next page will be the report selection page (Figure G) which will list the scan date, lab and # of animals scanned by sex. Click summary report (Figure H) to view the ultrasound scan data including EPDs. Click sire group report (Figure I) to view the sire average report for the calves scanned in that session. ■
