Save your data every 15 minutes to avoid session timeouts. Sessions will terminate after 20 minutes without clicking 'SAVE'.

Sire Summary Deadlines

In order to guarantee inclusion in the 2008 Sire Summary, all work must be submitted by:

- **Paper - must be postmarked by November 2, 2007**
- **Electronic - must be received by November 9, 2007**

By submitting your information by these dates, we guarantee that we will enter your records so that they will be included in the data sent to the National Cattle Evaluation. However, if you are not ready to wean by the deadline then you can either choose to send just the birth information and submit weaning updates at a later date or you could wait to submit the information when you do wean the calves. If you have any questions, please contact a member of the Registration Department.

Inactivation Report Fall 2006 Calving Records Deadline: October 29th

If we have not received information on females that were listed on your No Progeny Report in August, they will be inactivated on October 29th. We will mail out a listing of the females inactivated and ask that you submit the information to fulfill THR requirements without penalty.

Compute Option

- Intended for submitting calf data to fulfill THR progeny performance

requirements in the case when the calves are not intended to be kept as registered breeding stock.

- No performance certificates will be issued.
- They will not have EPDs, nor will they be eligible for transfer.
- Calves at a compute status may be moved to registered status provided they have met all the requirements for registration status.

Leased Animals

- If you are leasing an animal to another breeder then you are considered the lessor.
- If you are leasing an animal from another breeder then you are considered the lessee.
- Breeder of the calf is the owner or lessee of the dam at conception.
- Assessments on leased animals will be charged to the lessee and not the owner.
- Animals will appear on the THR reports for the lessee and not the owner.

Reminders:

- At this time, we are able to process the files received via REDS the same day or by the next business day. Therefore, if you submit calf data and non-owner bull permits are required in order to print a registration certificate or to transfer on entry be sure to have the permits on file prior to sending the file. Otherwise, the data will be processed and returned without applying the permits. We will not hold work pending permits.

- If an animal has been pre-registered (prior to weaning), when you are ready to submit that weaning data please note the animal's registration number. We ask that you NOT resubmit the record as a new calf registration with all data fields completed.

- If you are trying to submit a transfer entry via REDS on an animal where prior to sale you own the animal 100% and now have sold 50% ownership to another breeder and you will be retaining 50% ownership, then you will need to transfer the animal (effectively twice), once to the new owner and then to yourself as the other owner. The reason for doing this is because the questions regarding divisibility and the right to release AI certificates must be answered for all owners of the animals.

- When entering data via REDS - RRTS, be sure to remember that if you need a list of what the codes or fields mean, move your mouse over the title of the box, which should show you a ? . At this point, double click to view the box with the code descriptions; you will need to allow pop-ups on your computer in order to view this information.

- If an animal is scanned for ultrasound data outside the age range, which is bulls 320 - 440 days, and females 320-460 the data will be entered into the database, however the animal will not receive adjusted measurements. ■

Genetic Defects

As you probably noticed when you received your Spring Weaning Worksheet report, there has been an addition to the form. Directly above the first calf's information, is a statement confirming that all animals possessing characteristics of genetic defects were reported to RAAA. Preceding that statement is a box for you to check if the statement is true. This box must be checked for work to be processed. To learn more about the genetic defect policy review your Breeders Guide (Rules and Regulations, Section 3 or read Genetic Defects...Better Safe than Sorry found in the May/June ARA.
