PURPOSE:

- Report change in inventory seasons for females (check Spring box if moving from Fall to Spring).
- Report animals no longer active in herd.
- The Herd Inventory returned to the national office should indicate the list of animals, which will calve between 7/01/08 and 12/31/08.
- 45-day window for females scheduled to calve between 5/15/08 and 12/31/08, or 7/01/08 and 2/15/09.
- The animals reported as active on this inventory will be subject to annual assessment in December unless transferred.

Print - Yes or No	Weaning Date	Weaning Weight

- Include calves with disposal codes, which died before weaning.

- 2 = Stillborn / full term
- 3 = Died at birth due to a birth defect
- 4 = Died at birth for other reasons
- 5 = Born alive, but died before weaning due to disease
- 6 = Born alive, but died before weaning due to other reasons

- Include reason codes for females that do not have a calf record.

- 1 = Open, missed calving opportunity
- 2 = ET program / donor dam
- 3 = Moved to next calving season (Example - Fall to Spring)
- 4 = ET program / recipient cow
- 5 = Aborted / premature - use this reason code for cow rather than disposal of calf.
