November: Fall 2008 Heifer **Exposure Inventory**

A pre-printed inventory has been mailed to determine a member's yearling heifer inventory. The member is to indicate breeding season dates, exposure information, management group designation and disposal information. The heifer exposure inventory is due back by February 15, 2009. The heifer exposure is also available on-line for completion under member data REDS. The information required to complete the heifer exposure inventory is:

- Breeding season dates.
- •Whether or not the heifer was exposed, or will be exposed to breeding in pasture, A.I. or both - simply mark yes or no.
- Management group designation.
- Any coded disposal information.

December: Fall 2008 Annual **Assessments**

These will be billed starting in December with the 1st installment (20% of the total of the Fall THR assessments). The 1st installment billing will be included on your December statement. The Fall assessments will be billed in five monthly installments, unless you have eight animals or less, in which case you will then be billed in one installment.

Other Reminders

ET Calves

Parent verification is NOT required for ET calves to be registered in the RAAA. The rules and regulations do require that the ET service sire and ET donor dam be typed and a copy of their case record be on file in the National Office. If this information is not on file then the calf will be put on hold with a regtype Z which indicates that we do not have a case record on file for either donor dam or service sire or both.

Calf Registrations for Dams from Other Breeds

In order for calves to be registered out of females which are registered in another breed association, you must be the recorded owner of the dam in that respective breed association. IF NOT, we require a proof of purchase (bill of sale) that the offspring was purchased and not registered in that respective breed association. If you have questions, please contact the registration department.

REDS Data Protocol

Data received by 3:00 p.m. via REDS will be processed the same day. Therefore, if you know you will need non-owner bull permits or a DNA case record to be on file, PLEASE make sure the information is on file BEFORE you send in the data, otherwise the calves will go on hold. We do not look back on processed work to see if non-owner bull permits are available; your non-owner bull permit inventory is available on-line under member data REDS. So check your inventory, and when permits are available apply them on-line if by chance it is after work has been sent in electronically.

Inactive Dam Calf Registration

If you need to submit calf information for a female which does not appear active on your inventory (possibly has been inactivated) use the blank entry form at the top of your inventory under RRTS (REDS). Once we receive the calf information for an inactivated female we will reinstate her and charge the applicable fee according to her date of inactivation.

Non-owner Bull Permits

If a female or bull is on hold for a non-owner bull permit, please make sure that a permit is applied before you submit calf information for them. If the permit is not on file, then we will enter that calf with either an unknown sire or dam. A recalculation fee will apply when data has to be recalculated to add the sire or dam after the permit is applied.
