The RAAA shall incorporate genomic predictions into Genomic Enhanced Expected Progeny Differences (GE-EPDs) and may report GE-EPDs and genomic percentile ranks associated with the Zoetis HD 50K and i50K to Red Angus customers. In order to get Zoetis powered GE-EPDs from the RAAA, animals must be tested under this Agreement. RAAA will utilize 50K genotypes provided by Zoetis to perform parentage verification on all animals to the
